

**The Minnesota Wild Enter to Win a Wild Giveaway Courtesy of AAA
Official Rules**

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

1. ELIGIBILITY. The Minnesota Wild Enter to Win a Wild Giveaway Courtesy of AAA Sweepstakes (the "Sweepstakes") is only open to entrants who, as of the entry date, are permanent legal residents of the United States who are at least eighteen (18) years old. The Sweepstakes is void outside of the United States and where prohibited or restricted by law. Employees, officers and directors of the Minnesota Wild Hockey Club LP ("Wild") and The Auto Club Group ("Presenter"), and their respective parents, subsidiaries, affiliates, divisions, advertising and promotion agencies, and the immediate families (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether related or not) of each such employee, officer and director, are not eligible to enter. 3. HOW TO ENTER AND COMPLIANCE WITH OFFICIAL RULES

a. **HOW TO ENTER:** There are two (2) way(s) to enter this Sweepstakes.

(1) **TO ENTER ONLINE:** During the Entry Period, go to <https://responses.wild.com/2526AAAMNRTW> and follow the instructions for entry. All entries must be received by the Wild during the Entry Period. Potential winners may be required to show proof of being the authorized entrant.

(2) **TO ENTER VIA MAIL: LIMIT:** One (1) mail in entry per person and address (physical or email) in the Sweepstakes. All entries must be received by Wild during the Entry Period and become the exclusive property of the Wild. None will be acknowledged or returned. All entrants and entries subject to verification prior to the awarding of a prize, as are the eligibility, age and other claims of/information provided by a potential prize winner. Entries will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Wild.
